INVENTLIST, INC SOFTWARE END USER LICENSE AGREEMENT

GENERAL AGREEMENT.

INVENTLIST, INC SOFTWARE END USER LICENSE AGREEMENT. Thank you for selecting Software offered by Inventlist, Inc. (hereinafter referred to as “Licensor.”). Please review the terms of this License Agreement (hereinafter referred to as “Agreement”) carefully and completely. This Agreement is a binding legal agreement between you, the Licensee (hereinafter referred to as “you,” “your,” “yours,” as grammatically appropriate) and Licensor. By clicking, “I AGREE,” indicating acceptance electronically or in writing, accessing or using the Software, you agree to these terms, including payment of any applicable fees. If you do not agree to this Agreement, then do not indicate acceptance of the Agreement and do not use the Software.

1. AGREEMENT

- A. This Agreement describes the terms governing your use of the Software including content, updates and new releases (collectively referred to hereinafter as the “Software.”). This includes certain rights and responsibilities you have regarding use of the Software.
- B. This Agreement includes by reference as though fully written herein:
 - 1. Any Privacy Statement regarding Inventlist, Inc. that is, was, or may be provided to you by Licensor either electronically or in writing;
 - 2. Any additional Terms and Conditions as may be required to use the Software, including underlying third-party terms and conditions;
 - 3. Any additional terms, such as, but not limited to, activation terms, pricing and payment terms, etc., where applicable.

2. LICENSE GRANT, LIMITS AND RESTRICTIONS

A. LIMITS AND RESTRICTIONS

- 1. The Software is protected by intellectual property laws, including, but not limited to, copyright, trade secret, and any other applicable law. This Agreement grants you limited rights of use, including the right to install and use the Software in accord with the terms, conditions and restrictions of this Agreement. **ALL OTHER RIGHTS ARE RESERVED BY LICENSOR.**
- 2. For as long as you comply with the terms of this Agreement, and timely meet any payment obligations regarding use of the Software, Licensor grants to you and you alone a personal, limited, nonexclusive, non-transferable, revocable license to use the Software

for the period of use provided for in the ordering, installation and activation terms, as set forth in this Agreement.

3. You must use the Software only for the purposes intended by Licensor as described by Licensor.

B. You understand, acknowledge and agree that this Software is LICENSED and not SOLD. Further, you understand, acknowledge and agree you will not:

1. Provide access to the Software or any part of the Software to any third party;
2. Give the Software or any part of the Software to any third party;
3. Reproduce, duplicate, copy, deconstruct, reverse-engineer, sell, trade or resell the Software;
4. Transfer your license to the Software to any other party without express written permission from Licensor;
5. Attempt unauthorized access to any other Inventlist systems or programs that are not part of the Software;
6. Permit any third party to benefit from the use or functionality of the Software via a rental, lease, timesharing, service bureau, hosting service, or any other arrangement; or
7. Upload, host, use or access the Software via a timesharing, service bureau, virtualization, application hosting or other remote access arrangement.

Violation of any of the above terms constitutes a material breach of this Agreement, and Licensor may immediately revoke your license at its sole discretion.

3. CONTENT

A. You are responsible for your content. You are legally responsible for any and all information, data, text, software, music, sound, photographs, graphics, video, messages or other materials (“Content”) uploaded, posted or stored through your use of the Software. By using the Software, you grant Licensor a worldwide, royalty-free, non-exclusive license to host and use any Content provided through your use of the Software. You agree not to use the Software for any illegal purpose or in violation of any applicable laws, including state, federal or international law(s). Licensor is NOT responsible for any Content that may be lost or unrecoverable. Licensor is NOT responsible for any of the Content or data you provide through use of the Software.

B. You agree that you will not use the Software to do any of the following:

1. share, store, or in any way distribute financial data that is not in accordance with the law. Any user(s) suspected of having information which involves fraud, embezzlement, money laundering, insider trading, support for terrorism, or any other activity proscribed by law may have their account(s) terminated,

any financial data erased, etc. Further, such user(s) may be reported to law enforcement.

2. upload, post, distribute, link to publish, reproduce, engage in or transmit content or data that is illegal, fraudulent, defamatory, obscene, pornographic, profane, threatening, abusive, hateful, harassing, offensive, inappropriate or objectionable information or communications of any kind;
 3. upload, post, distribute, link to publish, reproduce, engage in or transmit content or data that would encourage or constitute an attack, “flaming,” “bullying,” of others;
 4. upload, post, distribute, link to publish, reproduce, engage in or transmit content or data that would encourage or constitute criminal or civil liability under any local, state, federal or foreign law;
 5. upload, post, distribute, link to publish, reproduce, engage in or transmit content or data that would impersonate another or falsely represent your identity, qualifications, or that constitutes a breach of any individual’s privacy, including posting images of anyone without their consent, or, in the case of a minor, a parent or guardian’s consent;
 6. upload, post, distribute, link to publish, reproduce, engage in or transmit content or data that constitutes a chain letter, pyramid scheme, spamming, flooding, virus, Trojan horse, worm or other disruptive or harmful software or data;
 7. upload, post, distribute, link to publish, reproduce, engage in or transmit content, data or information that is not legally yours and/or that may be protected by copyright or other proprietary rights, intellectual property or other ownership rights, including, but not limited to, derivative works, without prior permission from the copyright owner or intellectual property rights owner.
- C. The Software may include access to an online/community forum to exchange information with other users of the Software and the public. Licensor does not support, nor is Licensor responsible for, the accuracy of others’ content, hypertext links, etc. Licensor, in its sole discretion, may monitor Content provided on the community forum. Licensor reserves the right to disclose any information required to satisfy any legal obligations, operate the Software, and/or protect Licensor, its customers, users and guests. - E. You specifically agree that Licensor may assign or transfer ownership of this License to anyone without your consent to a Licensor Affiliate, a legitimate purchaser or buyer of Licensor via asset transfer, or a Licensor successor via merger.

4. PAYMENT

- A. For Software licensed on a payment or subscription basis, the following terms apply, unless Licensor notifies you in writing:
 - 1. Payment will be billed to you in U.S. dollars.
 - 2. Your account will be debited when you subscribe and provide payment information, unless stated otherwise in the program ordering or payment terms on the website for the Software.
 - 3. Payment is accepted in one of the following forms:
 - a. A valid credit card acceptable to Licensor.
 - b. A valid debit card acceptable to Licensor.
 - c. Sufficient funds in a cash-available bank account to cover an electronic debit of payment.
 - d. Other payment options Licensor may accept by providing written notice to you of the other available payment option(s).
 - 4. If your payment and/or registration information is inaccurate, or out of date, or incomplete, and you do not notify Licensor promptly about changes of this information, Licensor may immediately suspend or terminate your account, terminate this License, and/or refuse any further use of the Software.
 - 5. Licensor will automatically renew subscriptions on a timely basis at the then-current applicable subscription rate, unless the License has been cancelled or terminated per the terms herein.
- B. For any item sold by you to anyone, anywhere, worldwide, where the Software was involved in any aspect of the sale (*e.g.*, initial contact with buyer, initial exposure of item, actual close of sale, etc.) you agree:

Licensor has no liability for any third party.
 - C. Licensor may be required by law to send you communications regarding the Software or other goods and/or services. You agree that Licensor may send such communications to you or post them electronically on a Licensor-sponsored website. Licensor may also send business communications. You agree that Licensor may send such communications to you or post them electronically on a Licensor-sponsored website.

11. WAIVER OR MODIFICATION
